3. Hazards Identification.

Human

5. Fire-Fighting Measures.

Fumes containing carbon dioxide and carbon monoxide may be formed in large fires.

In case of fire use powder, foam, sand, water spray.

Avoid using large quantities of water.

In case of fire, cool the storage tank with water spray.

In case of fire, self contained breathing apparatus should be worn.

6. Accidental Release Measures.

Contain and collect spillage.

Absorb onto sand/kieselguhr or other inert material.

Failure to contain release must be notified to both the local authority and Geocel Limited.

Wear impervious gloves/overalls and eye protection while cleaning up the spillage.

7. Handling and Storage.
