# **GENERAL POWER TOOL SAFETY WARNINGS**

WARNING! Read all safety warnings, instructions, illustrations and specifications provided with this power tool. Failure to follow all instructions listed below may result in electric shock, fire and/or serious injury.

Save all warnings and instructions for future reference. The term "power tool" in the warnings refers to your mains-operated (corded) power tool or battery operated (cordless) power tool."

## WORK AREA SAFETY

- **a.** Keep work area clean and well lit. *Cluttered or dark areas invite accidents.*
- b. Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Power tools create sparks which may ignite the dust or fumes.
- c. Keep children and bystanders away while operating a power tool. Distractions can cause you to lose control.

## **ELECTRICAL SAFETY**

- a. Power tool plugs must match the outlet. Never modify the plug in any way. Do not use any adapter plugs with earthed (grounded) power tools. Unmodified plugs and matching outlets will reduce risk of electric shock.
- b. Avoid body contact with earthed or grounded surfaces, such as pipes, radiators, ranges and refrigerators. There is an increased risk of electric shock if your body is earthed or grounded.

- c. Do not expose power tools to rain or wet conditions. *Water entering a power tool will increase the risk of electric shock.*
- d. Do not abuse the cord. Never use the cord for carrying, pulling or unplugging the power tool. Keep cord away from heat, oil, sharp edges or moving parts. Damaged or entangled cords increase the risk of electric shock.
- e. When operating a power tool outdoors, use an extension cord suitable for outdoor use. Use of a cord suitable for outdoor use reduces the risk of electric shock.
- f. If operating a power tool in a damp location is unavoidable, use a residual current device (RCD) protected supply. Use of an RCD reduces the risk of electric shock.

## PERSONAL SAFETY

- a. Stay alert, watch what you are doing and use common sense when operating a power tool. Do not use a power tool while you are tired or under the influence of drugs, alcohol or medication. A moment of inattention while operating power tools may result in serious personal injury.
- b. Use personal protective equipment. Always wear eye protection. Protective equipment such as a dust mask, nonskid safety shoes, hard hat, or hearing protection used for appropriate conditions will reduce personal injuries.
- c. Prevent unintentional starting. Ensure the switch is in the off- position before connecting to power source and/or battery pack, picking up or carrying the tool. Carrying power tools with your finger on the switch or energising power tools that have the switch on invites accidents.
- d. Remove any adjusting key or wrench before turning the power tool on. A wrench or a key left attached to a rotating part of the power tool may result in personal injury.
- e. Do not overreach. Keep proper footing and balance at all times. This enables better control of the power tool in unexpected situations.

- f. Dress properly. Do not wear loose clothing or jewellery. Keep your hair, clothing away from moving parts. Loose clothes, jewellery or longhair can be caught in moving parts.
- g. If devices are provided for the connection of dust extraction and collection facilities, ensure these are connected and properly used. Use of dust collection can reduce dust-related hazards.
- h. Do not let familiarity gained from frequent use of tools allow you to become complacent and ignore tool safety principles. A careless action can cause severe injury within a fraction of a second.

## POWER TOOL USE AND CARE

- a. Do not force the power tool. Use the correct power tool for your application. The correct power tool will do the job better and safer at the rate for which it was designed.
- b. Do not use the power tool if the switch does not turn it on and off. Any power tool that cannot be controlled with the switch is dangerous and must be repaired.
- c. Disconnect the plug from the power source and/or remove the battery pack, if detachable, from the power tool before making any adjustments, changing accessories, or storing power tools. Such preventive safety measures reduce the risk of starting the power tool accidentally.
- d. Store idle power tools out of the reach of children and do not allow persons unfamiliar with the power tool or these instructions to operate the power tool. *Power tools are dangerous in the hands of untrained users.*
- e. Maintain power tools and accessories. Check for misalignment or binding of moving parts, breakage of parts and any other condition that may affect the power tools operation. If damaged, have the power tool repaired before use. Many accidents are caused by poorly maintained power tools.

- f. Keep cutting tools sharp and clean. Properly maintained cutting tools with sharp cutting edges are less likely to bind and are easier to control
- g. Use the power tool, accessories and tool bits etc. in accordance with these instructions, taking into account the working conditions and the work to be performed. Use of the power tool for operations different from those intended could result in a hazardous situation.
- h. Keep handles and grasping surfaces dry, clean and free from oil and grease. Slippery handles and grasping surfaces do not allow for safe handling and control of the tool in unexpected situations.

## **BATTERY TOOL USE AND CARE**

- a. Recharge only with the charger specified by the manufacturer. A charger that is suitable for one type of battery pack may create a risk of fire when used with another battery pack.
- b. Use power tools only with specifically designated battery packs. Use of any other battery packs may create a risk of injury and fire.
- c. When battery pack is not in use, keep it away from other metal objects, like paper clips, coins, keys, nails, screws or other small metal objects, that can make a connection from one terminal to another. Shorting the battery terminals together may cause burns or a fire.
- d. Under abusive conditions, liquid may be ejected from the battery; avoid contact. If contact accidentally occurs, flush with water. If liquid contacts eyes, additionally seek medical help. Liquid ejected from the battery may cause irritation or burns.
- e. Do not use battery pack or tool that is damaged or modified. Damaged or modified batteries may exhibit unpredictable behaviour resulting in fire, explosion or risk of injury.

- f. Do not expose a battery pack or tool to fire or excessive temperature. Exposure to fire or temperature above 130 °C may cause explosion.
- g. Follow all charging instructions and do not charge the battery pack or tool outside the temperature range specified in the instructions. Charging improperly or at temperatures outside the specified range may damage the battery and increase the risk of fire.

## SERVICE

- a. Have your power tool serviced by a qualified repair person using only identical replacement parts. This will ensure that the safety of the power tool is maintained.
- **b.** Never service damaged battery packs. Service of battery packs should only be performed by the manufacturer or authorized service providers.

# ADDITIONAL SAFETY WARNINGS FOR RECIPROCATING SAW

- a. Hold the power tool by insulated gripping surfaces, when performing an operation where the cutting accessory may contact hidden wiring. Cutting accessory contacting a "live" wire may make exposed metal parts of the power tool "live" and could give the operator an electric shock.
- b. Use clamps or another practical way to secure and support the workpiece to a stable platform. Holding the workpiece by hand or against your body leaves it unstable and may lead to loss of control.
- c. Keep hands away from the sawing range. Do not reach under the workpiece. Contact with the saw blade can lead to injuries.
- d. Apply the machine to the workpiece only when switched on. Otherwise there is danger of kickback when the cutting tool jams in the workpiece.

- e. When sawing, the guide plate must always face against the workpiece. The saw blade can become wedged and lead to loss of control over the machine.
- f. When the cut is completed, switch off the machine and then pull the saw blade out of the cut only after it has come to a standstill. In this manner you can avoid kickback and can place down the machine securely.
- g. Use only undamaged saw blades that are in perfect condition. Bent or dull saw blades can break, negatively influence the cut, or lead to kickback.
- h. Do not brake the saw blade to a stop by applying side pressure after switching off. The saw blade can be damaged, break or cause kickback.
- *i.* Do not support the workpiece with your hand or foot. Do not touch objects or the floor with the saw running. Danger of kickback.
- *j.* Use suitable detectors to determine if utility lines are hidden in the work area or call the local utility company for assistance. Contact with electric lines can lead to fire and electric shock. Damaging a gas line can lead to explosion. Penetrating a water line cause property damage or may cause an electric shock.
- *k.* When working with the machine, always hold it firmly with both hands and provide a secure stance. The power tool is guided more secure with both hands.

## ADDITIONAL SAFETY WARNINGS FOR BATTERY

- a. Do not connect the positive terminal and negative terminal of the battery to each other with any metal object (such as wire).
- b. Do not carry or store battery together with necklaces, hairpins or other metal objects.
- c. Do not pierce the battery with nails, strike the battery with a hammer, step on the battery or otherwise subject it to strong impacts or shocks.
- d. Do not solder directly onto the battery.

- e. Do not expose battery to water or salt water, or allow the battery to get wet.
- f. Do not disassemble or modify the battery.
- g. Do not place the battery in or near fire, on stoves or other high temperature locations. Do not place the battery in direct sunlight, or use or store the battery inside cars in hot weather.
- *h.* Do not place the battery in microwave ovens, high-pressure containers or on induction cookware.
- If you intend to store a battery for a period without use then store battery at room temperature (19°C to 25°C), charged to about 30 – 50% of capacity. When storing for very long periods boost charge the battery once per year to prevent over discharge.

The following information applies to professional users only but is good practice for all users:

## ADDITIONAL SAFETY WARNING FOR CONSTRUCTION DUST

The updated Control of Substances Hazardous to Health Regulations 1st October 2012 now also targets to reduce the risks associated with silica, wood and gypsumdusts. Construction workers are one of the at-risk groups within this because of the dust that they breathe: silica dust is not just a nuisance; it is a real risk to your lungs!

Silica is a natural mineral present in large amounts in things like sand, sandstone and granite. It is also commonly found in many construction materials such as concrete and mortar. The silica is broken into very fine dust (also known as Respirable Crystalline Silica or RCS) during many common tasks such as cutting, drilling and grinding. Breathing in very fine particles of crystalline silica can lead to the development of: Lung cancer Silicosis Chronic Obstructive Pulmonary Disorder/Chronic obstructive pulmonary disease (COPD)And breathing in fine particles of wood dust can lead to the development of Asthma. The risk of lung disease is linked to people who regularly breathe construction dust over a period of time, not on the odd occasion.

To protect the lung, the COSHH Regulations sets a limit on the amount of these dusts that you can breathe (called a Workplace Exposure Limit or WEL) when averaged over a normal working day. These limits are not a large amount of dust: when compared to a penny it is tiny – like a small pinch of salt: This limit is the legal maximum; the most you can breathe after the right controls have been used.

## HOW TO REDUCE THE AMOUNT OF DUST?

- 1. Reduce the amount of cutting by using the best sizes of building products. Use a less powerful tool e.g. a block cutter instead of angle grinder.
- 2. Using a different method of work altogether e.g. using a nail gun to direct fasten cable trays instead of drilling holes first.
- Please always work with approved safety equipment, such as those dust masks that specially designed to filter out microscopic particles and use the dust extraction facility at all time.

**WARNING!** Some dust particles created by power sanding, sawing, grinding, drill and other construction jobs contain chemicals known to cause cancer, birth defects or other reproductive harm. Some examples of these chemicals are:

- · Lead from lead-based paints.
- Crystalline silica from bricks and cement and other masonry products.
- Arsenic and chromium from chemically treated timber.
- Your risk from these exposures varies, depending upon how often you do this type of work. To reduce your exposure to these chemicals:
- Work in a well-ventilated area.
- Work with approved safety equipment, such as those dust masks that are specially designed to filter microscopic particles

## VIBRATION

The European Physical Agents (Vibration) Directive has been brought in to help reduce hand arm vibration syndrome injuries to power tool users. The directive requires power tool manufacturers and suppliers to provide indicative vibration test results to enable users to make informed decisions as to the period of time a power tool can be used safely on a daily basis and the choice of tool.

# SEE TECHNICAL SPECIFICATIONS IN THE INSTRUCTION MANUAL FOR THE VIBRATION LEVELS OF YOUR TOOL.

The declared vibration emission value should be used as a minimum level and should be used with the current guidance on vibration.

Calculating the actual period of use can be difficult and the HSE website has further information.

While working with this power tool, hand/arm vibrations occur. Adopt the correct working practices in order to reduce the exposure to vibration. This tool may cause hand-arm vibration syndrome if its use is not adequately managed.

Helping to minimise your vibration exposure risk. ALWAYS use sharp chisels, drills and blades. Maintain this tool in accordance with these instructions and keep well lubricated (where appropriate).

Avoid using tools in temperatures of 10°C or less. Plan your work schedule to spread any high vibration tool use across a number of days.



**NOTE:** The use of other tools will reduce the users' total working period on this tool.

## HEALTH SURVEILLANCE

All employees should be part of an employer's health surveillance scheme to help identity any vibration related diseases at an early stage, prevent disease progression and help employees stay in work.

## **RESIDUAL RISKS**

# UNPACKING

Unpack all parts and lay them on a flat, stable surface.

- · Remove all packing materials and shipping devices, if applicable.
- Make sure the delivery contents are complete and free of any damage. If you find that parts
  are missing or show damage do not use the product but contact your dealer. Using an
  incomplete or damaged product represents a hazard to people and property.
- Ensure that you have all the accessories and tools needed for assembly and operation. This also includes suitable personal protective equipment.

**WARNING!** The product and the packaging are not children's toys! Children must not play with plastic bags, sheets and small parts! There is a danger of choking and suffocation!

## 03 ASSEMBLING THE MACHINE

## **CHARGING YOUR BATTERY PACK**

The battery has been shipped in a low charge condition. Charge it fully before first use. Refer to the charger instruction manual for the details.

### TO REMOVE OR INSTALL THE BATTERY PACK (A1, A2)

Depress the battery pack release button to release and slide the battery pack out from your tool. After recharge, slide it back into your tool. A simple push and slight pressure will be sufficient.

## **BATTERY PACK POWER BAR**

The Li-Ion battery pack (7) is equipped with a POWER BAR which is used to give an indication of the battery pack's remaining charge. Press the POWER BAR button (8) to check battery charge as below. The LED will stay lit for approximately 5 seconds.

## SAW BLADES (B)

Different saw blades can be used with this product depending on the workpiece material.



**WARNING!** Always use saw blades according to the intended use! For example, never use a saw blade intended for working on wood for working on metal or vice versa!

Observe the technical requirements of this product (see section Technical specifications) when purchasing and using saw blades!

Some saw blades are very sharp and become hot during use! Handle them carefully! Wear protective gloves when handling saw blades in order to avoid injuries like burns and cuts!

Pull out and hold the tool-free blade change lever (10).

Insert a suitable saw blade (13) all the way into the blade socket (12) up to the stop and release the lever (10).



**NOTE:** The blade can be fitted and used in upwards or downwards going direction.

Pull on the saw blade (13) to test that it is firmly located in place. It should not be possible to pull it out.

Repeat the first step above to remove the saw blade (13) and insert a new one if required.



# 01 INTENDED USE

This product is intended for cutting wood and similar material e.g. MDF and chipboard, plastic and metal using the respective saw blade. The product must be used with the guide plate laying flat against the workpiece. It may not be used as a stationary product on a work bench.

# 02 OPERATION

## STROKE LENGTH ADJUSTMENT (C1-C4)

Adjust the stroke length according to the saw blade length and workpiece thickness; always ensure that the saw blade extends beyond the workpiece throughout the stroke.

Pull out the tool-free guide plate adjustment lever (11) to unlock the guide plate (1).

Adjust the guide plate (1) to the required position.

Push the tool-free guide plate adjustment lever (11) back to secure the guide plate (1) in position.

## **ON/OFF SWITCH (D)**

Press the lock button (4) to the left then press the on/off button (5) to switch the product on. To switch the product off just release the on/off button (5) When not in use, it is advised to return the lock button to the locked position(fully right) to avoid accidental re-start.

### SPEED CONTROL

The on/ off switch (5) is combined with a speed control. Adjust the speed directly with the on/ off switch. The speed is controlled by how far the trigger switch is depressed.

## AUTOMATIC LED WORK LIGHT (H)

The LED work light (2) will illuminate when the trigger switch is depressed slightly, and will automatically turn off a short while after the trigger switch is released. This provides additional light on the surface of the workpiece for operation in lower light situations.

## CUTTING (E1-E4)

Insert the saw blade (13) according to the intended application.

Hold the product with one hand on the handle (6), and with the other hand on the gripping surface (3).

Switch the product on and wait until it runs at full speed before placing it on the workpiece.

Place the guide plate (1) flat on the workpiece and move the product at an even speed.



**WARNING!** Always ensure the guide plate lays flat on the workpiece during operation! Do not try to make cuts with the product only held by hand!

## PLUNGE CUTTING (F)



**WARNING!** Plunge cutting may be used only on soft materials such as wood, gypsum plaster boards, etc.! Use only short saw blades!

Place the front edge of the guide plate (1) on the workpiece and switch the product on, wait until it runs at full speed.

Press the product firmly against the workpiece and plunge the saw blade slowly into the workpiece.

Continue to saw along the cutting line as soon as the complete surface of the guide plate (1) rests on the workpiece.

## POCKET CUTTING (G)

Use the following method to start a cut in the centre of the workpiece.

Use a suitable drill to drill a hole of at least 25 mm on the cutting line.

Insert the saw blade (13) that is fitted to the product into the hole and ensure it does not touch the workpiece.

Switch the product on and wait until it runs at full speed before moving the product.



**WARNING!** Always ensure the guide plate lays flat on the workpiece during operation! Do not try to make cuts with the product only held by hand!

#### OVERLOAD, TEMPERATURE AND CHARGING PROBLEM

## **CARE & MAINTENANCE**

#### MAINTENANCE

Your tool requires no additional lubrication or maintenance. There are no user serviceable parts in your power tool. Never use water or chemical cleaners to clean your power tool. Wipe clean with a dry cloth. Always store your power tool in a dry place. Keep the motor ventilation slots clean. Keep all working controls free of dust.

#### **RECYCLING AND DISPOSAL**

#### **DISPOSAL OF AN EXHAUSTED BATTERY PACK**

- Always store the product in a place that is inaccessible to children.
- We recommend using the original package for storage or covering the product with a suitable cloth or enclosure to protect it against dust.

#### TRANSPORTATION

- Switch the product off and remove the battery pack.
- · Attach transportation guards, if applicable.
- · Always carry the product by its handle.
- Protect the product from any heavy impact or strong vibrations which may occur during transportation in vehicles.
- Secure the product to prevent it from slipping or falling over.

This guarantee covers product failures and malfunctions provided the **Erbauer** power tool was used for the purpose for which it is intended and subject to installation, cleaning, care and maintenance in accordance with standard practice and with the information contained above and in the user manual. This guarantee does not cover defects and damage caused by or resulting from:

- Normal wear and tear, including accessory wear
- Overload, misuse or neglect
- · Repairs attempted by anyone other than an authorised agent
- Cosmetic damage
- · Damage caused by foreign objects, substances or accidents
- Accidental damage or modification
- · Failure to follow manufacturer's guidelines
- Loss of use of the goods

This guarantee is limited to parts recognised as defective. It does not, in any case, cover ancillary costs (movement, labour) and direct and indirect damage.
