Safety instructions

GENERAL POWER TOOL SAFETY WARNING



WARNING! Read all safety warnings, instructions, illustrations and specifications provided with this power tool. *Failure to follow all instructions listed below may result in electric shock, fire and/or serious injury.*

Save all warnings and instructions for future reference.

The term “power tool” in the warnings refers to your mains-operated (corded) power tool or battery-operated (cordless) power tool.

1) WORK AREA SAFETY

- a) **Keep work area clean and well lit.** *Cluttered or dark areas invite accidents.*
- b) **Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust.** *Power tools create sparks which may ignite the dust or fumes.*
- c) **Keep children and bystanders away while operating a power tool.** *Distractions can cause you to lose control.*

2) ELECTRICAL SAFETY

- a) **Power tool plugs must match the outlet. Never modify the plug in any way. Do not use any adapter plugs with earthed (grounded) power tools.** *Unmodified plugs and matching outlets will reduce risk of electric shock.*

- b) **Avoid body contact with earthed or grounded surfaces, such as pipes, radiators, ranges and refrigerators.** *There is an increased risk of electric shock if your body is earthed or grounded.*
- c) **Do not expose power tools to rain or wet conditions.** *Water entering a power tool will increase the risk of electric shock.*
- d) **Do not abuse the cord. Never use the cord for carrying, pulling or unplugging the power tool. Keep cord away from heat, oil, sharp edges or moving parts.** *Damaged or entangled cords increase the risk of electric shock.*
- e) **When operating a power tool outdoors, use an extension cord suitable for outdoor use.** *Use of a cord suitable for outdoor use reduces the risk of electric shock.*
- f) **If operating a power tool in a damp location is unavoidable, use a residual current device (RCD) protected supply.** *Use of an RCD reduces the risk of electric shock.*

3) PERSONAL SAFETY

- a) **Stay alert, watch what you are doing and use common sense when operating a power tool. Do not use a power tool while you are tired or under the influence of drugs, alcohol or medication.** *A moment of inattention while operating power tools may result in serious personal injury.*
- b) **Use personal protective equipment. Always wear eye protection.** *Protective equipment such as a dust mask, non-skid safety shoes, hard hat, or hearing protection used for appropriate conditions will reduce personal injuries.*

- c) **Prevent unintentional starting. Ensure the switch is in the off-position before connecting to power source and/or battery pack, picking up or carrying the tool.** *Carrying power tools with your finger on the switch or energising power tools that have the switch on invites accidents.*
- d) **Remove any adjusting key or wrench before turning the power tool on.** *A wrench or a key left attached to a rotating part of the power tool may result in personal injury.*
- e) **Do not overreach. Keep proper footing and balance at all times.** *This enables better control of the power tool in unexpected situations.*
- f) **Dress properly. Do not wear loose clothing or jewellery. Keep your hair and clothing away from moving parts.** *Loose clothes, jewellery or long hair can be caught in moving parts.*
- g) **If devices are provided for the connection of dust extraction and collection facilities, ensure these are connected and properly used.** *Use of dust collection can reduce dust-related hazards.*
- h) **Do not let familiarity gained from frequent use of tools allow you to become complacent and ignore tool safety principles.** *A careless action can cause severe injury within a fraction of a second.*

4) POWER TOOL USE AND CARE

- a) **Do not force the power tool. Use the correct power tool for your application.** *The correct power tool will do the job better and safer at the rate for which it was designed.*
- b) **Do not use the power tool if the switch does not turn it on and off.** *Any power tool that cannot be controlled with the switch is dangerous and must be repaired.*

- c) **Disconnect the plug from the power source and/or the battery pack from the power tool before making any adjustments, changing accessories, or storing power tools.** *Such preventive safety measures reduce the risk of starting the power tool accidentally.*
- d) **Store idle power tools out of the reach of children and do not allow persons unfamiliar with the power tool or these instructions to operate the power tool.** *Power tools are dangerous in the hands of untrained users.*
- e) **Maintain power tools. Check for misalignment or binding of moving parts, breakage of parts and any other condition that may affect the power tool's operation. If damaged, have the power tool repaired before use.** *Many accidents are caused by poorly maintained power tools.*
- f) **Keep cutting tools sharp and clean.** *Properly maintained cutting tools with sharp cutting edges are less likely to bind and are easier to control.*
- g) **Use the power tool, accessories and tool bits etc. in accordance with these instructions, taking into account the working conditions and the work to be performed.** *Use of the power tool for operations different from those intended could result in a hazardous situation.*
- h) **Keep handles and grasping surfaces dry, clean and free from oil and grease.** *Slippery handles and grasping surfaces do not allow for safe handling and control of the tool in unexpected situations.*

5) SERVICE

- a) **Have your power tool serviced by a qualified repair person using only identical replacement parts.** *This will ensure that the safety of the power tool is maintained.*

SAFETY WARNINGS FOR SANDER

- a) **Hold power tool by insulated gripping surfaces only, when performing an operation where the cutting accessory may contact hidden wiring or its own cord. Cutting accessory contacting a “live” wire may make exposed metal parts of the power tool “live” and could give the operator an electric shock.**
- b) *Take special care to protect yourself and people around against dusts, including the following:*
 - *All persons entering the work area must wear an appropriate dust mask specially designed for protection against harmful / toxic dusts, in addition to using the dust extraction facility and keeping work area well ventilated.*
 - *Children and pregnant women must not enter the work area.*
 - *Do not eat, drink or smoke in the work area.*
- c) *Some wood and wood type products especially MDF (Medium Density Fibreboard) can produce dust that can be hazardous to your health. We recommend the use of a dust mask with replaceable filters when using this product in addition to using the dust extraction facility.*
- d) *The power tool shall not be wet or applied in wet environment.*
- e) *The voltage of the power source must agree with the voltage specified on the rating label of the machine.*
- f) *Check the product, its power cord and plug as well as accessories for damage before each use. Do not use the product if it is damaged or shows wear.*
- g) *Double check that the accessories and attachments are properly fixed. One minute testing running in no-load condition will be helpful to identify any problems.*
- h) *Secure the workpiece. A workpiece clamped with clamping devices or in a vice is held more secure than by hand.*
- i) *Keep the handles dry to ensure safe control. Grip the product securely with two hands so you have full control at all times.*

- j) *Ensure that the air vents are always unobstructed and clear. Clean them if necessary with a soft brush. Blocked air vents may lead to overheating and damage the product.*
- k) *Switch the product off immediately if you are disturbed while working by other people entering the working area. Always let the product come to complete stop before putting it down.*
- l) *Do not overwork yourself. Take regular breaks to ensure you can concentrate on the work and have full control over the product.*
- m) *Always keep the power cord behind the power tool.*

The following information applies to professional users only but is good practice for all users:

ADDITIONAL SAFETY WARNINGS FOR CONSTRUCTION DUST

The updated Control of Substances Hazardous to Health Regulations 1st October 2012 now also targets to reduce the risks associated with silica, wood and gypsum dusts.

Construction workers are one of the at-risk groups within this because of the dust that they breathe: silica dust is not just a nuisance; it is a real risk to your lungs!

Silica is a natural mineral present in large amounts in things like sand, sandstone and granite. It is also commonly found in many construction materials such as concrete and mortar. The silica is broken into very fine dust (also known as Respirable

Crystalline Silica or RCS) during many common tasks such as cutting, drilling and grinding. Breathing in very fine particles of crystalline silica can lead to the development of:

- lung cancer
- Silicosis
- Chronic obstructive pulmonary disease (COPD).

And breathing in fine particles of wood dust can lead to the development of Asthma. The risk of lung disease is linked to people who regularly breathe construction dust over a period of time, not on the odd occasion.

To protect the lung, the COSHH Regulations sets a limit on the amount of these dusts that you can breathe (called a Workplace Exposure Limit or WEL) when averaged over a normal working day. These limits are not a large amount of dust: when compared to a penny it is tiny – like a small pinch of salt:

This limit is the legal maximum; the most you can breathe after the right controls have been used.

How to reduce the amount of dust?

1. Reduce the amount of cutting by using the best sizes of building products.
2. Use a less powerful tool e.g. a block cutter instead of angle grinder.
3. Using a different method of work altogether – e.g. using a nail gun to direct fasten cable trays instead of drilling holes first.

Please always work with approved safety equipment, such as those dust masks that specially designed to filter out microscopic particles and use the dust extraction facility at all time.

WARNING! Some dust particles created by power sanding, sawing, grinding, drill and other construction jobs contain chemicals known to cause cancer, birth defects or other reproductive harm. Some examples of these chemicals are:

- Lead from lead-based paints.
- Crystalline silica from bricks and cement and other masonry products.
- Arsenic and chromium from chemically treated timber.

Your risk from these exposures varies, depending upon how often you do this type of work. To reduce your exposure to these dusts:

- Work in a well-ventilated.
- Work with approved protective equipment, such as those dust masks that are specially designed to filter microscopic particles.



WARNING! Certain dusts, such as oak or beech dust, are considered as carcinogenic, especially in connection with woodtreatment additives (chromate, wood preservative).

Materials containing asbestos may only be worked by specialists. Use a dust extraction system suitable for the material as far as possible.

VIBRATION

The European Physical Agents (Vibration) Directive has been brought in to help reduce hand arm vibration syndrome injuries to power tool users. The directive requires power tool manufacturers and suppliers to provide indicative vibration test results to enable users to make informed decisions as to the period of time a power tool can be used safely on a daily basis and the choice of tool.

SEE TECHNICAL SPECIFICATIONS IN THE INSTRUCTION MANUAL FOR THE VIBRATION LEVELS OF YOUR TOOL.

The declared vibration emission value should be used as a minimum level and should be used with the current guidance on vibration.

Calculating the actual period of use can be difficult and the HSE website has further information.

The declared vibration total value has been measured in accordance with EN 62841- 1 and EN 62841-2-4 and may be used for compare one tool with another.

The declared vibration total value may also be used in a preliminary assessment of exposure.



WARNING! The vibration emission during actual use of the power tool can differ from the declared total value depending on the ways in which the tool is used:

- How the materials are grinded, cut or drilled.
- If the tool is in good condition and well maintained.
- Use correct accessory for the tool and ensure it is sharp and in good condition.
- The tightness of the grip on the handles.
- The tool is being used as intended by its design and these instructions.

While working with this power tool, hand/arm vibrations occur. Adopt the correct working practices in order to reduce the exposure to vibration. This tool may cause hand-arm vibration syndrome if its use is not adequately managed.



WARNING! Identify safety measures to protect the operator that are based on an estimation of exposure in the actual conditions of use (taking account of all parts of the operating cycle such as the times when the tool is switched off and when it is running idle in addition to the trigger time).

Note:

- The use of other tools will reduce the users' total working period on this tool.
- Helping to minimise your vibration exposure risk. ALWAYS use sharp chisels, drills and blades.
- Maintain this tool in accordance with these instructions and keep well lubricated (where appropriate).
- Avoid using tools in temperatures of 10 °C or less. Plan your work schedule to spread any high vibration tool use across a number of days.

Health surveillance

All employees should be part of an employer's health surveillance scheme to help identify any vibration related diseases at an early stage, prevent disease progression and help employees stay in work.

VIBRATION AND NOISE REDUCTION

To reduce the impact of noise and vibration emission, limit the time of operation, use low-vibration and low-noise operating modes as well as wear personal protective equipment.

Take the following points into account to minimise the vibration and noise exposure risks:

1. Only use the product as intended by its design and these instructions.
2. Ensure that the product is in good condition and well maintained.

3. Use correct attachments for the product and ensure they are in good condition.
4. Keep tight grip on the handles/grip surface.
5. Maintain this product in accordance with these instructions and keep it well lubricated (where appropriate).
6. Plan your work schedule to spread any high vibration tool use across a longer period of time.
7. Prolonged use of the product exposes the user to vibrations that can cause a range of conditions collectively known as hand-arm vibration syndrome (HAVS) e.g. fingers going white; as well as specific diseases such as carpal tunnel syndrome. To reduce this risk when using the product, always wear protective gloves and keep your hands warm.

RESIDUAL RISKS

Even if you are operating this product in accordance with all the safety requirements, potential risks of injury and damage remain. The following dangers can arise in connection with the structure and design of this product:

1. Health defects resulting from vibration emission if the product is being used over long periods of time or not adequately managed and properly maintained.
2. Injuries and damage to property due to broken attachments or the sudden impact of hidden objects during use.
3. Danger of injury and property damage caused by flying objects or poor power tool accessories.



WARNING! This product produces an electromagnetic field during operation! This field may under some circumstances interfere with active or passive medical implants! Assembly

01

Unpacking

1. Unpack all parts and lay them on a flat, stable surface.
2. Remove all packing materials and shipping devices, if applicable.
3. Make sure the delivery contents are complete and free of any damage. If you find that parts are missing or show damage do not use the product but contact your dealer. Using an incomplete or damaged product represents a hazard to people and property.
4. Ensure that you have all the accessories and tools needed for assembly and operation. This also includes suitable personal protective equipment.



WARNING! The product must be fully assembled before operation! Do not use a product that is only partly assembled or assembled with damaged parts!



Wear protective gloves for this assembly work and always lay the product on a flat and stable surface while assembling.

Follow the assembly instructions step-by-step and use the pictures provided as a visual guide to easily assemble the product!





Multi tool accessories

Tool attachments are available in various shapes and sizes. Below is only overview of the supplied tool attachments. Ask in store for more choices.

This product can also be used with accessories of other brands. Carefully read the safety warnings and observe the technical specification of the respective accessories before use and purchase.

The provided flange bolt with small head (15) enables the product to work with compatible sanding base plates which cannot be attached directly to the tool holder of this product.

03

Assembly of accessories

Attaching (Fig. A, B and C)

1. Open the flange release lever (1) fully from locking mechanism (Fig. A, step 1).
2. Turn the flange release lever (1) anti-clockwise (Fig. A, step 2) until the flange bolt (6) can be removed from the tool holder (7) (Fig. A, step 3).
3. Align the grooves on the suitable accessory with the ribs on the tool holder (7) at desired working position/angle (Fig. B).
4. Insert the flange bolt (6) into the tool holder (7) to keep the accessory in position (Fig. C, step 1) and then turn the flange release lever (1) clockwise to clamp the accessory firmly (Fig. C, step 2).
5. Close the flange release lever (1) to lock mechanism until you hear a “click” sound (Fig. C, step 3).
6. Check that the accessory is reliably clamped at desired angle and make adjustment if necessary.



WARNING! Check that the accessories are correctly attached. Incorrect or insecurely fastened accessories can come loose during operation and cause a hazard.



Depending on application needs, the plunge saw blade can also be assembled at $\pm 90^\circ$ (Fig. D). Never adjust the saw blade pointing backwards towards the handle (Fig. E).



WARNING! For safety reason, please ensure that the accessory is assembled with the correct orientation (Fig. F and G).

Detaching



WARNING! For all work, and when changing accessories, always wear protective gloves. Some tool attachments are sharp and hot after use! Handle them with care! Wear safety gloves when handling to avoid injuries like burns and cuts!



1. Open the flange release lever (1) fully from initial locking position (Fig. A, step 1).
2. Turn the flange release lever (1) anti-clockwise (Fig. A, step 2) until the flange bolt (6) can be removed from the tool holder (7) (Fig. A, step 3).
3. Remove the accessory from the tool holder (7).
4. Insert the flange bolt (6) into the tool holder (7) and then turn the flange release lever (1) clockwise to fix the flange bolt (6).
5. Close the flange release lever (1) to lock mechanism until hearing a “click” sound.

Sanding paper

Choosing the right sanding paper

Sanding paper is available with different grain sizes (grit) and for different material. The grain size is indicated with a number on the reverse of the sanding paper, the higher the number the finer is the grain size.

Grain size	Class	Application
< 80	Coarse	Removal of paint and varnish, preparation of rough surfaces.
80-120	Medium	For face sanding and removing small irregularities.
>180	Fine	Finishing, cleaning plaster and water stain from wood.



- Only use suitable sanding papers in terms of application and size. Do not use the papers that are bigger than the base plate of the product.
- Replace worn or damaged sanding papers immediately.
- Start with a coarse sanding paper and finish with a fine-grained one to achieve a satisfactory result.
- Do not use the same sanding paper on different materials, e. g. do not use the sanding paper that has been used for sanding metal to sand wood. Small metal particles remaining in the sanding paper will lead to scratches.

Attaching/Removing:

- With the hook-and-loop system, sanding paper (14) can be simply pressed on the sanding base plate (13). Align and attach the required sanding paper to the base plate and slightly press the sanding paper to fix it.
- Sanding paper can be simply removed by pulling off.



Always remove dust and chips from the sanding base plate (13) before attaching sanding paper (14) to reduce the wear of sanding base plate and sanding paper.

If one corner and/or edge of the sanding paper (14) is worn, it can be reattached and rotated by 120° to use the next corner and/or edge.



Use

Intended use

This product is intended for dry sanding and cutting on wood, plastic as well as plasterboard, especially for sanding small surfaces (e.g. corners or edges) and plunge/flush cutting.

This product can also be used with attachments of other popular brands when they are suitable for the tool holder (incl. pins) and locking flange. Carefully read the safety warnings and observe the technical specification of the respective attachment before purchase and use.

Before you start

01 Protection



Controls

01 On/Off switch (Fig. 1)

Mode	Action	Application
On	Shift the On/Off switch (2) forward to "1"	The power tool will run continuously.
Off	Shift the On/Off switch (2) backward to "0"	Switch the power tool off.

02 Automatic LED work light

LED work light (8) will automatically illuminate the working zone when you press the On/Off switch (2).



WARNING! Do not look directly into LED light!

03 Speed dial (Fig. J)

Limit the maximum speed using the speed dial (4) depending on material and application.

1. Turn the speed dial (4) clockwise to increase the speed.
2. Turn the speed dial (4) anti-clockwise to decrease the speed.

Operation

01 Sanding

- Ensure the workpiece is free of obstacles like nails or screws before operation. Remove them if required. Where possible, secure smaller workpieces to prevent them from moving under the product.
- Hold the product with one hand on the head of housing or front section of hand grip and with the other hand on the hand grip.
- Switch the product on and wait until it runs at full speed before placing it on the workpiece.
- Move the product slowly and steadily over the workpiece surface in parallel and overlapping strokes.
- Only apply the least possible pressure to keep the product flat on the workpiece. Higher pressure will not increase but lower the performance of the product, increase wear of the sanding paper and leads to uneven results.
- Work with dust extraction system particularly when sanding coats of varnish as the varnish could melt and smear the surface of the workpiece and the sanding paper.
- Keep the product moving at all times, do not stop in one position to avoid grooves.
- Lift the product from the workpiece before switching it off.

02 Cutting (Fig. K, L and M)



WARNING! Only perform plunge cutting into soft materials such as plasterboard or soft wood! Never attempt to conduct any plunge cutting into hard materials such as metal! Use only the appropriate saw blade for cutting! If you are unsure when cutting, consult with an experienced person – risk of injury!

Switch the product off, let it come to a complete stop and disconnect it from the power supply if the attachment gets stuck in the workpiece. Only then free the jammed attachment.

The provided saw blades can be used for plunge or flush cutting as shown in Fig. K, L and M.

- Mark the cutting line and ensure that the workpiece will not move during operation.
- Ensure that the cutting depth of the saw blade is higher than the workpiece thickness.
- Switch the product on, align the saw blade with the marked cutting line and place the saw blade on the workpiece.
- Apply light pressure and carefully lead the saw blade into the workpiece until the desired depth is reached.
- Lift the product from the workpiece before switching it off.

03 Scraping (Fig. N)



WARNING! Switch the product off, let it come to a complete stop and disconnect it from the power supply if the attachment gets stuck in the workpiece. Only then free the jammed attachment.

- Switch the product on before placing the scraper on the workpiece.
- Adjust the product to a proper scraping angle according to the material of workpiece.
- Keep the product at a flatter angle to the workpiece when processing soft materials, such as wood. Otherwise the scraper can cut into the workpiece.
- Move the product forward at an even speed.
- Only apply as much pressure as necessary. Higher pressure will not increase but lower the performance of the product and leads to uneven results.
- Lift the product from the workpiece before switching it off.



After use

- Switch the product off, wait for complete stop, disconnect it from the power supply and let it cool down.
- Detach the tool attachments from the product.
- Check, clean and store the product as described below.



Care & maintenance

5. Check for worn or damaged parts. Replace worn parts as necessary or contact an authorised service centre for repair before using the product again.



Do not use chemical, alkaline, abrasive or other aggressive detergents or disinfectants to clean this product as they might be harmful to its surfaces.

Maintenance

Your power tool requires no additional lubrication or maintenance.

There are no user serviceable parts in your power tool.

Before and after each use, check the product and accessories (or attachments) for wear and damage. If required, exchange them for new ones as described in this instruction manual.

01 Power cord

If the replacement of the supply cord is necessary, this has to be done by the manufacturer or his agent in order to avoid a safety hazard.

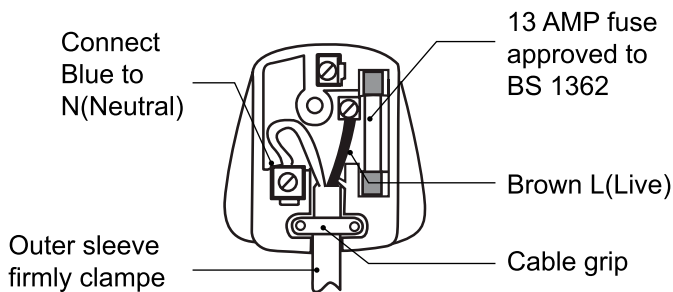
02 UK plug (only for UK market)

Replacement of the plug shall always be carried out by the manufacturer of the tool or his service organization and follow the instructions below.

IMPORTANT: The wires in the mains lead are coloured in accordance with the following code:

Blue – Neutral Brown – Live

As the colours of the wire in the mains lead of this product may not correspond with the coloured marking identifying the terminals in your plug, proceed as follows. The wire, which is coloured blue, must be connected to the terminal, which is marked with N or coloured black. The wire, which is coloured brown, must be connected to the terminal, which is marked L or coloured red.



WARNING! Never connect live or neutral wires to the earth terminal of the plug, which is marked with E.

Only fit an approved 13 Amp BS 1363 or BS 1363/A plug and the correctly rated fuse. If in doubt, consult a qualified electrician.

If a moulded plug is fitted and has to be removed take great care in disposing of the plug and severed cable, it must be destroyed to prevent engaging into a socket.

Transportation
